In accordance with the regulations of the Ministry of Foreign Affairs of the People's Republic of China, all foreigners going to China on business purpose need to present,when applying for a business visa,an official invitation letter from the authorized Chinese organisation.The organisers will coordinate and submit the applicant's details to the Chinese authorities,the invitation letter will then be sent by fax to the applicant with a copy to the Chiness Embassy/Consulate concerned.Upon receipt of the invitation letter,the applicant is required to apply for an entry visa from the Chiness Embassy/Consulate concerned by presenting his/her passport,a recent photograph, a completed visa application form along with the required visa application fee.

You may also apply for a tourist visa for entry into China,which means you do not need to obtain invitation letter.

Please contact your local visa office of the Chinese Embassy/Consulate for Tourist Visa Processes.

**Note:**

1. Passport must be valid for at least **SIX MONTHS** beyond the intended date of entry to China.
2. Please make necessary copies of this form for each applicant.For Clarity,please type or print.
3. Charge for issuing of the invitation letter US\$22.00 for one person.
